Opt-in to receive updates

In May 2018 all companies handling personal data must ensure they adhere to the [General Data Protection Regulation \(GDPR\)](#). The NIA is committed to following the rules of GDPR and as such must request that all members individually opt-in to receive email notifications, newsletters, event information and all other correspondence relevant to their company's membership.

Individuals will need to visit <http://eepurl.com/doOCyD> complete the sign up form and opt-in to the mailing groups they wish to receive information and updates from. **It is very important that each individual is completing this opt-in themselves as indirect consent is not permitted.** Individuals will be free to review information held, update preferences or request deletion at any time, as it is equally important to the NIA that data is current and accurate.

To ensure your company is making the most of membership and that the NIA are getting the right information to the right people, it is important they sign up to the relevant mailing groups described below.

NIA MEMBER

All individuals opting in should tick this box so the system identifies them as an NIA member.

SUBSCRIPTION CONTACT

Subscription invoices are automatically sent out to members in April. One contact must sign up to this list to receive and process the invoice.

NIA UPDATES

The NIA send out weekly and monthly newsletters and ad-hoc updates to inform members what is happening within Government, the media, industry and NIA business groups. All members interested in receiving these updates should opt-in to this list.

MAIN MEMBER CONTACT

Please ensure one or two members of staff sign up to be the main point of contact with the NIA.

PRESS CONTACT

The press contact will be first to receive NIA press releases and will be first point of contact on any media issues. This can be more than one person.

EVENT PROMOTION

NIA hold a number of events throughout the year, including an annual conference, business group meetings and bi-annual conferences on new build and decommissioning. Opt-in to be kept up to date about these and events hosted by partner companies where NIA has secured discount incentives for its members.
