We are delighted to share with you the news of our Quarter 4 and Year End position for the SME agenda target.

As we have previously communicated, we have designed, built, and implemented an improvement plan to ensure efficiencies and accuracy on the way the SME spend is reported.

It was clear from the beginning that the purpose of the improvement plan was not the numbers but the substance of the SME Agenda: to do the right thing, to support our SME community and to have all our prime partners aligned to our effort

One team - eleven Sellafield Ltd's Divisions, NDA Commercial Standards team and more than thirty suppliers - worked together to identify and highlight the best individual and joint practices.

We can report 100% response from all suppliers involved, and the training sessions were beneficial for understanding and further appreciation of a mutual effort.

As a result, we are proud to share that Quarter 4 resulted in 37.8% SME spend and the Year End 2021/22 was 34.25% SME spend, exceeding the 33% target.

I would like to thank my Sellafield colleagues that continue to contribute to the SME agenda, the NDA Commercial Standards team for their exemplar support and of course our supply chain who support the SME agenda delivering stellar results.

"As an organisation, we are extremely focused on improving how we work with SMEs and, although we are currently working with over 25 SMEs on our projects, we are currently creating an SME collaboration strategy to increase this number.

#### Focus on major projects

To kick off a new series of features on major infrastructure projects at Sellafield, we are putting the spotlight on the SIXEP Continuity Project (SCP).

These projects are links in a chain - emptying the legacy facilities through to safely storing waste for decades to come.

SCP, one of the Programme and Project Partners (PPP) key projects, is currently in the construction phase having this year completed the final concrete pour on its foundation slab weeks ahead of schedule.

When complete it will help ensure the continued operation of the Site Ion Exchange Effluent Plant (SIXEP) which removes radioactivity from various site effluent streams before discharge to sea.

SIXEP is one of the key site effluent treatment plants because of the role it plays in treating effluents from High Hazard and Risk Reduction programmes i.e. the First Generation Magnox Storage Pond and the Magnox Swarf Storage Silo.

The existing SIXEP facility has been in operation since 1985, was originally designed to operate for 25 years and will be needed until around 2060. Having SCP will enable us to continue treating effluent waste for decades to come.

The project has two main components: A new build facility to be constructed north of the existing SIXEP facility which will replace the effluent treatment function of SIXEP; Modifications to the existing plant to allow effluent to be diverted to the new facility.

#### National social value award for Sellafield Ltd

Sellafield Ltd has been highly commended in the National Social Value Awards in the category Public Sector Leadership.

This award recognises organisations that lead the way in embedding social value into their business culture, processes and systems to ensure the needs of their communities are being met.

Tracey West from our social impact team said: "We have done a lot of work with people over recent years and we are really leading the way in how we deliver social value, collaboration being key.

"We have worked on building social impact into our business for some time now and recently re-issued our strategy under the banner of Social Impact Multiplied, known as SiX. The name reflects the amount of work that we have been doing with partners, stakeholders and suppliers to increase the amount of impact our funding and resource delivers in the local communities.

"We describe social impact as the long term effect that our company actions have on people and our community. There is embedded social impact which we achieve through the high level of local employment and our commitment to apprenticeships and graduate programmes. Then there is the additional value delivered through deliberate activities to address social and economic issues in the local community. Receiving this award reinforces the positive impact of our collaborative working in delivering social value."
