## Quality hot topic: mitigating risks from counterfeit, fraudulent and suspect items (CFSI)

Counterfeit items are those that have been 'confirmed' to be a copy, imitation or substitute and has been represented, identified, or marked as genuine, and/or altered by a source without legal right with intent to mislead, deceive or defraud.

Recently, there has been a concerning trend in CFSIs. A shortage of various electronic components in the global supply chain has impacted product availability and lead times, resulting in an elevated risk of CFSI products emerging in the nuclear industry.

### IF IT IS TOO GOOD TO BE TRUE, IT PROBABLY IS!

### Red flags to look for include:

- Cheaper than expected prices
- Shorter lead times than other suppliers
- Sudden availability of obsolete, or hard to source, goods
- Slight differences in packaging or labels
- Spelling mistakes or subtle changes in font or spacing

Recent examples are two separate instances of counterfeit Human-Machine Interface (HMI) screens identified in the projects supply chain; suspect packaging and typographical errors were found during the sub-contract goods inspection process.

### Mitigating against CFSI involves awareness, prevention, detection, control and learning.



## Quality hot topic (continued)

### Mitigating CFSI risks includes:

- raising CFSI awareness,
- conducting supplier evaluations,
- implementing appropriate assurance for COTS items,
- carrying out detailed receipt and dispatch inspections,
- refraining from deviating to alternate supply routes unless absolutely necessary,
- if a different supplier is needed, ensuring additional due diligence in the procurement process.

### LINC with Sellafield

LINC with Sellafield will go live on Atamis on Monday 16th January 2023

As a result applications will no longer be accepted via CTM, any supplier that has already qualified for LINC has been automatically qualified in Atamis and your details transferred. If you haven't previously logged into Atamis, email: <u>OneNDA.CommercialSystems@nda.gov.uk</u> so that a password reset can be sent to enable access to your account. If you've already logged into Atamis, your accounts will have to be merged.

As of **01/02/2023**, the DPS will be transitioned to Atamis. This means that any new or in-flight registrations must be completed in CTM by **13/01/2023**. ### Operational Technology Group (OTG)

Operational Technology covers everything from plant sensors for measuring levels, temperatures etc through to the major plant control systems that make our site factories work.

Sellafield Ltd's Operational Technology Group (OTG) have created an offsite presence to grow a sustainable capability to manage the OT on the Sellafield site for years to come.

The Engineering Centre of Excellence at Leconfield allows us to deliver more effectively for the Sellafield site through closer collaboration with the supply chain.

Apprentices are being given a unique training experience through a new collaboration between organisations.

For the first time, Jacobs have taken on two control system apprentices through a partnership with Sellafield which will see them join the next cohort learning their trade at Leconfield.

They will also be joined by apprentices from both Forth Engineering and PAR systems. This partnership is about growing the capabilities of businesses across West Cumbria, not just Sellafield, to help all local companies improve and develop their skill sets.




