#### Sellafield and Partners Help Children Write Their Own Futures

A life-changing new reading programme launched by the Programme and Project Partners at Sellafield and its supply chain has seen 111 volunteers step up to support primary school age children in West Cumbria.

Using an innovative and secure digital platform from reading charity <u>Chapter One</u>, each volunteer is paired with a child who they will spend the next year supporting.

Luke Richardson, Programme and Project Partners head of social impact, said: "A child who can read is set up for life, not just because they do better at school and have better job prospects, but because they are happier and more confident. Government statistics show 1 in 5 children don't have a book of their own at home, and 1 in 3 children from disadvantaged backgrounds aren't able to read at the required level, we're now hoping to change this using the power of our partnership at Sellafield."

#### **Quality Hot Topic: Growing Nuclear Quality Talent**

Quality is a critical enabler to delivering our important Sellafield mission. A key challenge has been to attract, develop and retain quality talent, at Sellafield and across our supply chain; the attrition rate has increased, and quality resources are scarce, not just for the nuclear industry or Cumbria, but across the UK.

Our strategic focus has continued to enhance our quality capability, establishing robust competency framework and career pathways, holding recruitment campaigns, and establishing resource-enhancement contracts. so that we can meet current and future business needs. We have significantly in quality invested specific apprenticeships in the nuclear field. Nuclear Welding Inspection Technician (NWIT) and Quality Engineer degree apprenticeships have included, to date, 67 apprentices. Three cohorts of NWIT apprentices have now successfully passed their end point assessment and have been deployed to fill resource gaps within the Quality capability. The first two cohorts of Quality Degree Apprentices (QDA) have now graduated with a BEng and completed their apprenticeship, and are mobilised across our Value Streams and Proiects.

Dave Tomlinson, Quality Lead for Inspections and Certification Services, said: "Both these schemes have enabled Sellafield Ltd to significantly reduce the risks associated with capability. Apprentices from the first cohorts are now involved in the training and mentoring of the younger cohorts, and there are still significant efforts and focus on their development. Whilst we have continued to promote the benefits of these apprenticeships for the industry and the region, through key industry groups, regional and national events, the CQI Nuclear Next Generation (NNG) and the STEM ambassador programme; take up of the schemes by the supply chain has been limited, and we would be happy to work in collaboration with our colleagues to foster more support for the schemes."

#### Supply Chain Capability Programme Update

The Supply Chain Directorate Capability Programme has continued to make real progress in the delivery of the six Learning Pathways, covering Category Management, Supply Chain & Market Analysis, Supplier, Contract & Risk Management, Sourcing & Negotiation, Sustainability and Behavioural capabilities. A huge thank you to everyone involved in helping attain the continued milestones achieved!

Following the launch of the Foundation & Practitioner stages of the Category Management Pathway, we have completed 10 clinics and 13 different workshops on this Pathway alone, covering topics from Price & Cost Modelling, Options Generation & Evaluation and Category Strategy Implementation Planning. These activities have in turn helped with the great progress made on the Category Family Plan & Category Strategies.

However, it is not just the Category Management Pathway that is progressing! Across the programme as a whole over 80 workshops & clinics have been delivered, 392 documents and templates have been developed, 160 Foundation level certificates have been issued and 178 capability assessments have been undertaken. These are some fantastic numbers and real credit to all involved.

Into the future, there are 20 Behavioural clinics scheduled from January to March as well as another 4 Category Management clinics. Continuing the Supplier, Contract & Risk Management Pathway, we have 2 further 'Introduction to the New SRM Handbook' briefings taking place in February and a Supplier Relationship Management Introductory Workshop pilot in March following on from the Contract Management Introductory Workshop pilot held 30-31 January.

#### **SME Spotlight**

#### The Herne Group – BEPDT JV Supplier Relationships

Since July 2020, The Herne Group has been working with the Box Encapsulation Plant (BEP) Delivery Team Joint Venture (BEPDT JV) to develop and implement a customised Supplier Relationship Management (SRM) programme that promotes collaboration, shared learning, and value creation between BEP and its suppliers.

On the BEP project, the Joint Venture manages the supply chain, with Sellafield providing Intelligent Client oversight. The Supplier Relationship Management (SRM) programme was established to ensure the timely delivery of critical design and manufacturing packages on BEP, by fostering stronger communication and building trust between suppliers and the BEPDT JV. Through these efforts, the program aimed to instil confidence in the JV that the packages would be delivered as scheduled, in a mutually beneficial manner.

The programme uses co-developed, targeted survey questions to measure collaboration, relationships and trust, focusing on communication, mutual respect and teamwork. The feedback data is used to identify and resolve immediate and emerging issues and support LfE and opportunities for improvement. Supplier feedback scores are monitored and reported monthly to show variance from previous reports, with additional feedback-sharing sessions taking place with BEPDT JV managers and project leaders. After two years of implementation, the SRM programme is now an established and valuable tool for addressing and resolving issues that arise within the project. The wide base of feedback data is useful for identifying areas for continual improvement and the SRM team is readily available to rapidly respond as any new issues emerge across the project.

"The BEPDT JV SRM programme has made a positive impact on the way supply chain management is approached and executed on the project," says Herne Group's Director of Training, Mike Preston. "It has been well-received at multiple levels for its effectiveness and has established a system of communication and improvement between suppliers, BEPDT JV, and Sellafield Ltd. This has led to more effective problem-solving, stronger relationships, and a deeper understanding of supply chain challenges. Along with our supporting behavioural and team development workshops, the programme has been instrumental in resolving underlying issues that caused conflict, enabling more positive and collaborative working with the supply chain."

The Herne Group is a Wigan-based micro-SME consultancy that specialises in Programme Management, Project Controls and PMO establishment, primarily in the nuclear sector. As well as supplier relationships, Herne's training division provides non-technical training such as leadership development, team building and stakeholder engagement. Becoming a supplier to BEP has allowed Herne Group to develop new nuclear professionals and bridge the skills gap in the industry by providing entry-level opportunities to young people in the local community.

KAEFER's focus on LEAN allows it to generate as close to zero waste as possible by optimising processes and continuously improving them.

#### Sellafield Partnership Expands its Northern Supply Chain

The Programme and Project Partners (PPP) are appointing their latest suppliers to help transform projects at Sellafield and boost growth in the north. Severfield Nuclear and Infrastructure Limited and William Hare Limited have won contracts to deliver steelwork, worth a combined total of £249 million, over the next 17 years.

#### Would you like to be a charity trustee and make a difference?

In the charity sector, the passion to make a difference is the key currency. From the charity's point of view, the guiding principle of their organisation needs to be one which is close to the hearts of those setting its strategic direction on the board. Trustees also need to have a passion for the cause for their own sake.

Trustees are the group of people (also called the Board of Trustees) who act in the charity's best interests, set the strategy or plan, make key decisions and oversee the running of a charity.

Being a trustee offers the opportunity for professional development. It can let you gain experience of strategy and leadership, and boost your CV. It will give you experience of being a non-executive director, such as setting a strategic vision, influencing and negotiation, and managing risk.

If you're considering a charity board role, first consider what you care about. Make sure you can evidence and express this commitment. Perhaps yourself or a loved one has been affected by the problem the charity supports people with? (Whether it's a health condition or an experience, such as poverty, domestic violence or homelessness). Or maybe it's a cause you have always been involved with in however small a way. Many of the larger charities advertise their trustee vacancies, but smaller ones may only openly recruit for Chair roles. It is worth contacting the smaller organisations to express your interest, in case of any other roles now or in the future.

Words of advice from a passionate trustee "For those considering becoming a trustee, I would wholeheartedly recommend it, and would say that you shouldn't worry about whether you're qualified enough, or whether you have enough life experience to make a difference. As long as you care about the cause and are willing to dedicate time and energy, then go for it! Being a trustee isn't always easy, but you'll learn a lot and you'll make a difference to at least one person's life, and probably a lot more than you'll ever realise.

#### Sellafield Collaborative Working Recertification

After a thorough audit from Lloyd's Register Quality Assurance Ltd (LRQA), Sellafield Ltd has achieved official recertification for its collaborative working practices for the key collaborate business relationships within the supply chain, associated with delivering products and services supporting the delivery of the Sellafield mission.

The 2 week audit was undertaken against the requirements of ISO 44001: 2017. The audit focused on a review of the effectiveness of the Collaborative Working Arrangements and to verify that these continue to be maintained in conformance with the requirements of ISO 44001:2017. Sellafield Ltd views collaborative working with its supply chain as vital to the safe, secure and efficient running of its sites.

Sellafield Ltd continues to focus on further developing and embedding its Collaborative Working arrangements in support of and in accordance with the requirements of ISO44001, for its collaborative working practices. ISO44001 is a standard identifying, developing and managing collaborative business relationships within or between organisations that supports strategic delivery. Our collaborative business relationships are aligned ways of working under ISO 44001, and feature as a golden thread and an integral part within our Supplier Relationship Management (SRM) programme.

As part of our SRM systematic approach, it is our objective to further integrate our collaborative working principles as part of our strategic business relationships. Collaboration is key to delivering our scope successfully, and focus on developing mutually beneficial relationships within the supply chain is vital for Sellafield and the overall industry.


